
SASS October 2024

Shotgun Certificate Renewal

There have been many tales of woe regarding shotgun certificate applications and renewals in SASS. My certificate expires early February 2025. Having updated readers on statistics and bulletins in the newsletter whenever they have been released, I am going to record the progression of my renewal application. Five years ago, pre-pandemic (just), my renewal only took nine days to complete. Hampshire Constabulary now recommend that applications are made eight weeks in advance, plus a further eight weeks for the new compulsory GP report (introduced 1st November 2021). Counting back from my expiry date plus a week for the Christmas holiday, I contacted Medcert (who I recommended as "police recognised" a few months back, on good authority). The £60.00 fee advertised, turned out to be + vat, so I ended up paying £72.00. I am happy to pay that as long as their service is as good as they claim. Within a week (quicker than you could get an appointment) my GP asked for my consent to disclose my medical records to Medcert, which I did. Meanwhile, Hampshire Constabulary Firearms (HCF) sent a renewal reminder letter to the wrong address, not even the same street. Eventually (ten days later) I received it. I called the Firearms number, which is only available weekdays between 10am-12pm. Apparently, HCF have had that as my address for some time and were surprised that there was no record of a HCF visit to check the security/cabinet at the address. I have lived at the same address for over twenty years, that is four shotgun certificate renewals. I will leave the potential consequences of such a mistake to your imagination. I believe the error has been corrected by HCF, but asked for confirmation in writing just in case, which I received. As a further precaution, I have upgraded my CPSA membership to full member, so that if it is required, I have their back-up. I will report progress, or not, in due course.

Ower, 27th October

The last shoot of the month had polar reviews. Two squads of three shot the layout at Ower, one squad had very little problems and the other had nothing nice to say. The only thing that they agreed on was that stand four had a few issues, the weather was good and Robbo had to make his own breakfast! Get well soon Denise, you have plenty of recouperation time because Bisley is not on the November shoot list. Well done Capp for winning the cartridges, it is nice to see a different name at the top of the scores. Well done Badger for the highest actual, 44/50. Badger is creeping up the top shots league, his 2nd place is now over halfway between Thumb Boy in 3rd and Sturat in 1st. Could there be an upset before the end of the year?
